Ms. Darr Tindall called the meeting to order at 8:08 pm.

**Agenda:** Mr. Short moved adoption of the agenda which was seconded by Mr. Schiffman. All in favor (AIF).

**Consent Agenda:** Pull minutes. Mr. Short moved adoption of the consent agenda as amended which was seconded by Ms. Virginia Birkby. AIF.

### **Old Business:**

**Election of Officers:** (Action)

Ms. Virginia Birkby nominated Mr. Ron Schiffman to the office of President. AIF.

Mr. Schiffman proceeded to chair the meeting.

**Smoke Test Report:** (Information) Mr. Chick reported the completion of a smoke test of the district on August 9<sup>th</sup>. He had expected that there would be more customers with water drain connections to the collection system than were in fact found. The test turned up one significant exception of a customer with multiple buildings on their property with a connection from a collection basin receiving rain water runoff into the district system leading to the wastewater treatment plant. He was surprised to not find any smoke coming through the ground giving indication of broken lateral lines but suspected the water table level and sandy soil condition to not be conducive for this part of the test. Testing for infiltration would proceed in the fall through more camera work with a focus on lateral customer connections.

The board directed Mr. Chick to communicate to the customer involved a requirement to correct the improper drain water connection within sixty days of the date of the notice letter.

**Mixer Status:** (Information) Mr. Chick reported the failed mixer was in for repair by Flygt and expected to obtain quotes from another supplier for installation where the repaired unit would be shelved for future emergency use.

#### **New Business:**

**LGIP Signature Authorization Letter:** (Action) Ms. Virginia Birkby moved execution of the Local Government Investment Pool signature authorization letter (attached) which was seconded by Mr. Seifer. AIF.

### Manager Report August 18, 2017

## **SANITARY**:

The U.V. system has been having some problems lately. We have been working with Aquionics (the manufacturer) and Cannon Beach Electric on identifying the cause of the problem. The system has been experiencing multiple tripping issues. These incidents appear to be associated with strart-up, after intermittent periods of low flow, when the lamp units are turned off. New breakers for the lamps will be installed, as a first means of pin-pointing the problem. If this does not solve the issue, we will need to schedule a tech from Aquionics to come out for a site visit.

Biosolids work is complete and irrigation site brush cutting continues

The radiator on the generator at the WWTP has developed a small leak. We are monitoring it daily. One has been ordered and will be installed by Grafs Automotive when it comes in. Cummins does not have one in stock, so it will be some time before it is received.
